3. Profile of skills and competences

The holder of this document has the competence to carry out various tasks in pharmacies. S/he

- is qualified to serve, guide and advise customers relating to selecting a product and using non-prescription medication, health and care articles and aids
- is qualified to order goods, receive goods, put on price stickers and place goods, finish various orders and shipments, and carry out clerical tasks and accounts
- is qualified to assist the pharmaceutical staff in preparing and selling prescription medication
- is qualified to participate in pharmacy production work and perform filling and finishing medication
- is able to carry out this work in a proper manner bearing in mind health, safety and the environment

The final training comprises the modules 1: The occupation and society, 2: Pharmacy, 3: Logistics, 4: Medication, 5: Nursing articles and merchandise, 6: Drugs and herbal medicine, 7: Prescription work, 8: Customer relations.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects. Pharmacy technicians are authorized as health care personnel and come under legislation governing the practising of the profession.

The education/training corresponds to completed upper secondary education	Grading scale / Pass requirements The grading scale is as follows: 6 – 5 – 4 – 3 – 2 – 1 – 0. Grade 6 is the best grade. Grades 2 - 6 are passing grades. Subjects with both examination grades and overall achievement grades have been passed when the examination grade is 2 or better. "Exempted" may be used instead of numeral grades in some subjects. This means that the pupil/external candidate has previously passed corresponding or more comprehensive training in the subject. Adults may also have their attained competence assessed instead of receiving a numeral grade. The assessment "Approved" equals a passing grade.
Access to next level of education/training The training/education together with further instruction in general studies subjects qualifies the candidate for admission to higher education	International agreements
