The holder of this document has the competence to work with wall and floor coverings in private houses, public buildings, industrial and business companies, on ships, drilling platforms and other offshore installations. S/he

- is qualified to choose, treat and use materials, tools and equipment, use materials optimally and has good product familiarity
- is qualified to assess appropriate pre-treatment and application methods on different surfaces
- is capable of displaying good work techniques and using tools appropriately, has cleanliness and order, as well as creativity and aesthetic sense when carrying out work
- is capable of planning, carrying out and inspecting own work performance based on given quality requirements
- is qualified to work in compliance with standards, legislation and regulations that apply to the paperhanging area of study and to working in line with health, environment and safety requirements
- is capable of finding subject material on his/her own and of using relevant aids
- is capable of reporting on completed work tasks
- knows the importance of the subject to society, its history and development possibilities
- is familiar with the factors that influence profitability and quality requirements

The final on-the-job training in a company comprises the modules 1: Wallpapering and wall plastic work, 2: Floor work and profiles, 3: Product and methods knowledge, 4: Business economy studies.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

<b>Additional information</b> The first two years of the training take place in a school/training centre. This comprises a total of 19 periods per week in general studies subjects, 47 periods per week in specialised subjects and four periods per week in elective subjects. This is followed by one year of training in a school or company, and finally one year of value creation in a company. Adult students may in some cases be exempted from the requirement for the general studies subjects.
